	<b>Corporate Stall</b>	\$1500.00 including GST (Inquire for additional facilities)

### CONDITIONS AND GUIDELINES FOR FOOD AND OTHER STALLS

- All the moneys paid are refundable if the booking is canceled before 30.09.2007 or if the stall is not approved.
- All stall holders to must have their own current public liability insurance.
- Tea and Coffee are not allowed to be served or sold.
- Only **VEGETARIAN FOOD** is allowed to be sold at this function.
- **FOOD STALL HOLDERS MUST BRING A 8 FT. X 8 FT (recommended size) CANOPY TO HAVE THEIR ON SITE COOKING UNDER COVER.** Please contact HCA for further help regarding this issue.
- Stall holders are required to set up their stall before 10.00 a.m. and start operating from 11 AM on the day and finish at 9 PM and must vacate by 10.30 PM. All vehicles must be removed from loading / unloading area stall entry area by 11.00 A.M. It is strongly recommended to arrive ASAP.
- Unless approved by HCA, selling of food other than the approved stalls, collection of any money and distribution of any pamphlet is strictly prohibited.
- Food stall holders must obtain a license from Auburn Council. This must be obtained by contacting Anita Ugarkovic on Ph. 02 9735 1231 between office hours.
- Food items on sale must be properly covered and handled in accordance with the health standards of the state of New South Wales.
- The stallholder occupies and uses the stall at the stallholder's sole risk. The stallholder releases to the full extent the Hindu Council of Australia and the Fairfield Showground from and against all claims and demands of any kind and from any liability which may arise because of any accident, damage, death or injury to any person or property in or around the stall.
- It is advised to bring your own trolley to carry their goods to the stall and avoid congestion and delays.
- Vehicle access to the entry gates is for loading and unloading before 10.30 AM or after 9 PM for short period only. The security staff will remove any vehicle seen at other times. All vehicles used in the stall area must be driven at a walking pace with hazard lights on.
- Promotional banners and signage can only be exhibited with prior written approval from HCA.
- Any rubbish created or left by the stallholder at the site of the stall will be charged to the stallholder. All rubbish must be kept in the bins provided. The stall area must be left clean. A clearance note in writing must be obtained from HCA before leaving the grounds.
- Do not remove, replace, refit or re-locate the stall or its contents, any problems must be informed to the HCA.
- Each Stall holder will be notified upon approval with location map of the non-transferable stall
- It is the responsibility of the Stallholder to pay all taxes including GST.
- To abide by any other conditions, which may be, issued by HCA for safety and smooth operation of the stalls.
- Stallholder found negligent of the above conditions, agrees to vacate and the stall and the rent will not be refundable.
